

LIST OF ACHIEVEMENTS FOR APPLICANTS

As high quality of scientific achievements it is understood that at least one of the following scientific accomplishment in the discipline to which the candidate applies has been obtained:

- 1) authorship or co-authorship of a scientific monograph or a chapter in a scientific monograph - according to the in accordance with the list of publications of the Minister responsible for higher education and science, current as of the date of adoption of the Resolution of the Senate of the Jan Kochanowski University of Kielce on the principles of recruitment of candidates foreigners to the Doctoral School of the Jan Kochanowski University of Kielce in the academic year 2022/2023;
- 2) authorship or co-authorship of a scientific article published in a scientific journal or in reviewed materials from international conferences - in accordance with the list of journals referred to in art. 267 paragraph. 3 of the Act - Law on Higher Education and Science (Journal of Laws of 2020, item 85 as amended), valid as of the date of the resolution of the Senate of Jan Kochanowski University of Kielce on the principles of recruiting candidates for the Doctoral School of Jan Kochanowski University of Kielce in the academic year 2021/2022. authorship or co-authorship of a scientific article published in a scientific journal or in peer-reviewed materials of international conferences - in accordance with the list of journals referred to in Art. referred to in Article 267, paragraph 3 of the Law on Higher Education and Science (Journal of Laws 2022, item 574, as amended), current as of the date of adoption of the resolution of the Senate of Jan Kochanowski University of Kielce on the principles of recruitment of foreign candidates to the Doctoral School of the Jan Kochanowski University of Kielce in the academic year 2022/2023;
- 3) leading a research project or participating in the realization of a research project financed by a national or international third-party funding;
- 4) practical application of the results of scientific research or development works, including granted patent or implementation of scientific results in different forms;
- 5) scholarship awarded by a foreign institution.

In the case of the achievements referred to in points 1) and 2), at least 25% of the candidate's participation in the publication is considered as co-authorship.

The scientific achievements described above must be documented in paper form, such as:

- copy of the first page(s) of a scientific monograph or scientific article containing names of all authors, title, publishing house, place of publication, month and year of publication, ISBN, eISBN, ISSN, eISSN, ISMN or DOI;
- statements of co-authors of a scientific monograph, or a chapter in a scientific monograph, about the candidate's original contribution to it; in the case of a scientific article a statement by a correspondent author about the candidate's original contribution is sufficient;
- confirmation of patent or implementation of scientific results in a different form;
- statement of the research project manager containing information about the number, source of financing, duration and purpose of the project, the role of the candidate demonstrating the achievement and the full realization in the project according to its tasks and scopes;
- confirmation of obtainment of a scholarship obtained by a foreign institution.
