The highest quality of scientific achievements is considered to be the presence in the scientific portfolio, in the discipline in which the candidate applies, of at least two of the following achievements or one for a minimum of 70 points:

- authorship or co-authorship of a scientific monograph or chapter in a scientific monograph

 in accordance with the list of publications of the minister responsible for higher education
 and science, current on the date of the resolution of the Senate of the Jan Kochanowski
 University in Kielce regarding the rules for the recruitment of candidates to the Doctoral
 School of the Jan Kochanowski University in Kielce for the academic year 2025/2026;
- 2) authorship or co-authorship of a scientific article published in a scientific journal or in peer-reviewed conference materials in accordance with the list of journals referred to in Article 267 para. 3 of the Law Higher Education and Science Act (Journal of Laws of 2024, item 1571), current on the date of the resolution of the Senate of the Jan Kochanowski University in Kielce regarding the rules for the recruitment of candidates to the Doctoral School of the Jan Kochanowski University in Kielce for the academic year 2025/2026;
- 3) management of a research project or participation in the implementation of a research project funded as part of a national or international competition;
- 4) practical application of scientific research results or development work, including the granting of a patent or implementation of the results of scientific activity in another form;
- 5) receipt of a scientific scholarship awarded by a foreign institution;
- 6) artistic or project work of significant importance.

In the case of achievements referred to in points 1 and 2, co-authorship is considered to be at least 25% participation of the candidate in the publication.

The scientific achievements referred to above should be documented in writing, in the form of:

- 1) photocopies of pages of a scientific monograph or scientific journal, containing the names of the author or authors, the title of the scientific monograph or scientific article, the name of the publishing house, place of publication, month and year of publication, number: ISBN, eISBN, ISSN, eISSN, ISMN, or DOI;
- 2) statements of co-authors of a scientific monograph, chapter in a scientific monograph regarding the percentage contribution of the candidate to the scientific monograph, chapter in a scientific monograph, or in the case of a scientific article, a statement of the corresponding author;
- 3) confirmation of granting a patent or implementation of the results of scientific, artistic, or project activity in another form;

- 4) statements of the project manager containing information about the project number, source of funding, duration, and purpose of the project, the role that the person demonstrating the achievement plays in the project, the scope of tasks performed by them, and the effects of the project;
- 5) confirmation of receipt of a scientific, artistic, or project scholarship awarded by a foreign institution;
- 6) documentation of artistic or project achievements.
