- Middle Ages: Gregorian chant, organum, motet, mass, canon, chanson, ballata, madrigal
- Renaissance: motet, chanson, madrigal, cano
- Baroque: motet, cantata, oratorio, opera, canon, prelude, fugue, sonata, concerto
- Classicism: Sonata, Concerto, Symphony
- Romanticism and Neo-Romanticism: sonata, concerto, symphony, overture, symphonic poem
- The 20th century: styles, genres and trends characteristic of individual composers
